

Is a legacy gift for you? Gifts by will, trust or beneficiary designation — also known as bequests, are the most common way people plan their legacies. Following requests by some of the Wexford members, the Foundation Trustees have created the Wexford Legacy Society to recognize those supporters who wish to be remembered or make a difference by including the Foundation in their estate plans.

The Wexford Legacy Society is open to any current or past members who wish to give back to the local community following their time at Wexford. For those who wish to be recognized for their contribution, the Foundation's Trustees have established recognition levels for donor bequests. Recognition levels start at \$25,000 (Gold) rising through \$100,000 (Platinum), to \$250,000 and above (Diamond).

Members who decide to include the Wexford Foundation in their estate



plans during 2022 at the gift level of \$25,000 or more will become Charter Members of the Wexford Legacy Society, helping to ensure that the Foundation can continue to improve the lives of those in need for many years to come.

FREQUENTLY ASKED QUESTIONS



1. Do I have to make a legally binding pledge to join the Legacy Society?

No. Your gift plans can be revised at any time should your circumstances change. This is part of the reason that legacy gifts are such a good fit for so many people.

2. I've named Wexford Foundation in my final plans, but don't feel comfortable disclosing the amount of my legacy gift publicly. Am I still able to join the Legacy Society?

Yes. While disclosure of the current value of the legacy gift amount to the Foundation is required to join the Legacy Society, we will keep the amount of your legacy gift private, if that is your preference, by not including your gift in Legacy donor levels when published.

3. Will I have to pay tax on the gift I leave in my will?

Any amount you leave to a charity will usually be exempt from inheritance tax, however we recommend that you consult your tax adviser regarding the tax implications specific to your circumstances.

4. Can I add a gift to Wexford Foundation into my existing will?

Yes. If you've already made a will and want to make an update, you can amend your will with a document called a Codicil.

5. Do I have to tell Wexford Foundation that I have left them a bequest in my will?

That is entirely up to you, though we would be pleased if you let us know so we can recognize your generosity and possibly use your support to encourage others.

6. Can I leave a bequest to Wexford Foundation in memory of a person?

Yes, a charitable gift is a wonderful way to recognize and remember someone you knew and who made a difference in your life. You can definitely specify this in your will.

7. What options do I have for specifying the value of my bequest?

You can specify a dollar amount, a percentage of your estate or the current value of any assets such as property, life insurance, charitable remainder trusts, valuables or other kinds of gifts.

8. Who should I contact to learn more about the Legacy Society?
